MOTION FOR COMPUTER ACCESS

WILLIAM WINDSOX ("PLAINTIFF") HEREBY
FILES THIS "MOTION FOR COMPUTER ACCESS,"
AND SHOWS THE COURT AS FOLLOWS:

1. THE PLAINTIFF IS IN ELLIS COUNTY JAIL.
THE JAIL DOES NOT HAVE A LAW LIBRARY.
THE PLAINTIFF NO LONGER HAS USE OF A
COMPUTER OR HIS FILES.

2. THE PLAINTIFF HAS MANY ISSUES
PENDING IN THIS CASE. HE HAS APPEALS
PENDING IN CALIFORNIA AND MONTANA.
HE HAS ANOTHER CIVIL ACTION IN ELLIS
COUNTY AND IS PREPARING A 42 USC 1983
LAWSUIT AGAINST OFFICIALS IN ELLIS
COUNTY. HE HAS CIVIL ACTIONS PENDING
IN IOWA AND MISSOURI, AND HE
MAY NEED TO FILE ONE IN GEORGIA.

3. THE PLAINTIFF REQUIRES FULL-TIME
ACCESS TO HIS COMPUTER, HIS ELECTRONIC
AND PAPER FILES, A SCANNER, A

PRINTER / COPYER, AND A TAPE RECORDER.
THE PLAINTIFF NEEDS AN INTERNET
CONNECTION TO USE VERSUSLAW.COM,
YATTOU.COM, AND GOOGLE.COM FOR LEGAL RESEARCH.

4. THE PLAINTIFF IS PRO SE. THE PLAINTIFF
HAS A CONSTITUTIONAL RIGHT TO REPRESENT
HIMSELF AND SEEK REDRESS OF GRIEVANCES.
THE PLAINTIFF HAS A PROPERTY
RIGHT IN HIS LAWSUITS THAT MAY NOT
BE INFRINGED BY ANY JAIL, LAW
ENFORCEMENT, OR COURT. PRISONERS HAVE
A WELL-ESTABLISHED RIGHT TO A LAW
LIBRARY AND LEGAL INFORMATION.

5. AS LAWSUITS ARE NOW ABSOLUTELY
DEPENDENT ON COMPUTERS AND ELECTRONIC
FILES, IT IS A VIOLATION OF THE
PLAINTIFF'S RIGHTS TO THE PROCESS
AND EQUAL PROTECTION TO BE DENIED
USE OF HIS COMPUTER AND
ELECTRONIC FILES.

WHEREFORE, THE PLAINTIFF PRAYS THE COURT WILL ORDER THE FOLLOWING:

1. WILLIAM M. WINDSOR SHALL BE GIVEN FULL-TIME USE OF HIS LAPTOP AND FILES BY THE ELLIS COUNTY SHERIFF'S DEPARTMENT AND ANY OTHER LAW ENFORCEMENT AUTHORITIES, JAILS, OR PRISONS UNTIL THIS CASE AND ALL APPEALS ARE EXHAUSTED;
2. WILLIAM M. WINDSOR SHALL BE SIMILARLY ASSURED ACCESS TO AN EXTERNAL HARD DRIVE, SCANNER, PRINTER, COPIER, AND PAPER THAT HE WILL PROVIDE;
3. WILLIAM M. WINDSOR SHALL BE SIMILARLY PROVIDED INTERNET ACCESS OR ALLOWED TO USE A VERIZON WIRELESS SERVICE AT HIS OWN EXPENSE;
4. FAILURE TO FULLY HONOR THE TERMS OF THIS ORDER WILL BE CONTEMPT OF COURT;
5. AND SUCH OTHER RELIEF AS THE COURT FEELS IS APPROPRIATE.
