MOTION FOR SANCTIONS AND PERJURY AGAINST SEAN D. FLEMING

William M. Windsor ("Windsor") files this MOTION FOR SANCTIONS AND PERJURY AGAINST SEAN D. FLEMING.

1. On February 21, 2014, Defendant Sean D. Fleming ("Fleming") signed a sworn affidavit under penalty of perjury, and that affidavit has been filed in this case. Fleming's affidavit says that as a result of Windsor's lawsuit against him, he has become "frightened to engage in any type of public debate or public forum or to exercise my Constitutional rights."

2. Yet on May 6, 2014, Fleming of Madison Heights, Michigan published this on Joeyisalittlekid.blogspot.com: "Here is one thing if Windsor wants to have a name calling fest I am all for it. I bet he can not hang. He can meet me in at one of those places on 8 mile where **I will tear him apart** like the ogre he is."

3. And on May 7, 2014, he published this on Joeyisalittlekid.blogspot.com: "I have Decided that I will be creating a series on Lawless America, Citizen Gran Juries, and more. As of

this time it is called The Slanderers www.theslanderers.com There will be a weekly segment. I will go into the depths of Lawless America, interview people who have left the revolutionary movement. Go over the stories they gave, see where they are, how they feel about the movement, etc. I will also go into the coming up of the movement lawless America, Grip, and also about the Maid of the Mist, and also 1st Communications....”


4. So, Sean D. Fleming who signed a sworn affidavit saying how frightened he is of “any type of public forum” announced he will be doing a weekly YouTube show all about Windsor, a public forum in which he will undoubtedly defame Windsor up one side and down the other. He has, in Windsor’s opinion, committed perjury. Windsor believes Fleming lied because he wanted the Court to feel sorry for him and provide support for his unsuccessful efforts to get out of the lawsuit.

5. A search of Joeyisalittlekid.blogspot.com reveals that Fleming posted one-hundred-seventy-three (173) published statements on that site from February 21, 2014 when he signed the sworn affidavit to May 13, 2014. He lied to the court.

6. Windsor asks this Court to sanction Fleming for filing a false sworn affidavit.

7. Windsor asks this Court to pursue criminal charges against Fleming for perjury.



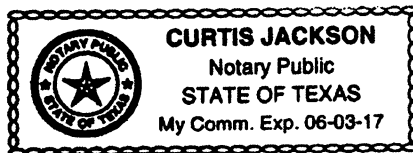
